The Chrysler Pacifica Hybrid and Amazon Family Present: The Jillian Michaels Ultimate Parent Sweepstakes ("Promotion") is sponsored by FCA US LLC, 1000 Chrysler Drive, Auburn Hills, MI 48326 ("Sponsor"), and is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 ("Administrator"). The Promotion consists of an instant win game ("Game") and a sweepstakes ("Sweepstakes").

- 1. PROMOTION PERIOD:** The Promotion begins on June 14, 2017 at 12:00 PM Eastern Time ("ET") and ends on July 14, 2017 at 11:59:59 PM ET ("Promotion Period"). Administrator's computer is the official clock of the Promotion.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) U.S. States and the District of Columbia who are eighteen (18) years or older and a licensed driver at the time of entry. **Valid U.S. driver's license required to claim Sweepstakes Grand Prize (defined below). No more than the above quantities of Game Prizes will be available in the Promotion.
